WHICH SITUATIONS CAUSE ADMINISTRATIVE DETENTION?

If you have entered Turkey irregularly/ If your entry visa to Turkey has expired / If you do not have a residence permit or your residence permit has expired / If as an asylum seeker or as a refugee you are located outside the borders of your designated satellite city / If you are apprehended while attempting to leave Turkey irregularly / Other situations where you do not possess a document granting you the official right to stay in Turkey.

APPLICATION OF INTERNATIONAL PROTECTION/ ASYLUM REQUEST

Authorities present in the detention center are entitled to receive your application / It is free of charge /You may make your request either written or oral form to the authorities, and in your own language / It is recommended that the request be made in writing, so it is recorded properly / You may contact with United Nations High Commissioner for Refugees (UNHCR) in relation to your application /Your asylum application and your personal data must be kept confidential by the Turkish state authorities, and they are prohibited from sharing this information with the officials in your country.

BASED ON THE TURKISH PENAL CODE, WHAT CAN BE CONSIDERED A CRIMINAL CHARGE?

Drugs crimes (production, sale, use, supply etc of drugs) / Homicide / Felonious injury/ Burglary/ Robbery/ Pandering (pimping)/possession of weaponry (Firearms and cutters) /Smuggling (goods and humans) / And similar considered as a criminal offense across the globe.

DURING ALL THESE PROCESSES:

There can be no act committed that is against human dignity and honor / There can be no torture or ill treatment / You cannot be prevented from the use of your legal rights noted above / You cannot be forced to sign any document that you don't understand/ You cannot be forced to give a statement, or to testify without a translator/ Upon your request, you have the right to legal assistance during the entire process/ Upon your request, you have the right to referral to a doctor or a hospital for medical treatment
